The following information is provided to assist the reader to understand the accounting statement and/or the Annual Governance Statement

**1. Expenditure under S137 Local Government Act 1972**

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2024-25 was £10.81 per elector.

In 2024-25, the Council made payments totalling £\_NIL\_ under section 137. These payments are included within 'Other payments' in the Accounting Statement.

**2. Additional assets in the form of two picnic tables, two benches and a range of gardening tools have been acquired through a Keep Wales Tidy scheme and the donation of a picnic bench in memory of the husband of a Council Member. Other items from Keep' Wales Tidy have included fruit trees and plantings which are in Donkey Field, Bettisfield.**

**3. A number of contingency funds that had been budgeted for were not drawn down which has resulted in the increase in general reserves. Members will be seeking to designate some of the funds during 2025/26 for future maintenance and potentially enhance £24k of Section 106 funding to be used at Pendas Park Playground in Penley at the early part of 2025/26.**

**4. It has still not been possible to identify an alternative energy supplier for the street lighting due to difficulty in gaining quotes against an unmetered power supply.**

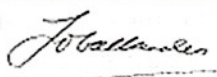

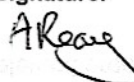

## Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Maelor South Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis of Qualification

#### Accounting Statement

In my opinion, the Accounting Statement does not properly present the Council's receipts and payments and financial position:

- The Council did not provide all of their bank statements therefore, I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments and financial position.

#### Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Section 50 of the Democracy and Boundary Commission Cymru etc. Act 2013 requires the Council to publish its audited accounts online. Regulation 5 of the Accounts and Audit (Wales) Regulations 2014 requires the Council to publish the Annual Governance Statement alongside the accounts. Regulation 15 of the 2014 Regulations requires the Council to publish along with the accounts, any certificate, opinion, or report issued, given or made by the Auditor General. The Council has failed to publish its qualified audit reports from previous years.
- The Council does not publish a register of members' interests as required by section 81 of the Local Government Act 2000.

### **Arrangements to secure economy, efficiency and effectiveness in use of resources**

I am unable to conclude whether or not the Council has proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources

- The Council did not provide their full insurance schedule for audit. Therefore, I am unable to conclude whether or not the Council has proper arrangements in place to secure economy, efficiency and effectiveness in use of its resources.

### **Other matters and recommendations**

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

### **Approval of Payments**

The Council currently approve their payments within a closed circle of councillors, as the minutes state 'finance report presented' at each Council meeting. It is unclear if these councillors convene as a properly constituted committee. Unless the members convene as a committee they cannot lawfully approve payments.

In order to ensure transparency for electors, we recommend that the Council presents the full finance report in their open meeting minutes.

### **Clerk's Contract**

The Clerk's contract payment terms state a £ per hour amount which is assessed periodically.

We recommend that the Council and clerk negotiate a National Association of Local Councils salary scale point.

### **Information provided for audit**

The Council did not provide invoices or remittance advices to support all of their transactions.

We recommend that the Council obtains an adequate standard of supporting information for each transaction and provides this information for prospective audits.

There are no further matters I wish to draw to the Council's attention.
